May 2, 2017

- 1. Members present: Jim Peters, Jim Evers, Fred Atchison, Michael Steinle, Kate Campbell, Megan Richardson, Shelly McColm.
- Jim P. reported that Audrey Coleman couldn't attend today's meeting, but sent an update on progress with Lawrence Kids calendar purchase. LKC purchasing agreement is being reviewed/edited by both attorneys.
- 3. Treasurer's report:
 - -There are a couple of items that need to be changed after the conversion to the online QuickBooks program. Megan will speak to Sam Bhakta and possibly Kevin Kressig to resolve the issue.
 - -Megan mentioned a large portion of our yearly expenses is the weekly cost of meals. The board researched other options a couple of years ago and decided to stay at The Eldridge.

- 6. Fred asked if we would like to seek a grant for one or two shelter boxes this year. The board agreed this is something we should pursue and Fred will speak to Lynn O'Neal about initiating the process.
- 7. Jim E. mentioned the LCR Foundation may qualify for a grant toward the purchase of the LKC.
- 8. Jim P. will not be present May 10 and Fred will run the meeting.
