- 4. Foundation/LKC Report by Audrey Coleman:
  - In November, a meeting took place to discuss future development structure. Steve Lane, Kate Campbell, Jim Peters and Audrey Coleman attended. Discussed next initiative to secure major sponsor (ca. \$5000) with McDonalds. Jim Peters and Steve Lane will pursue. Group plans to meet again with Tobin and Chip/Jay to explore two tiered "ad buyer" (current system) vs. "friend"/partner annual subscription.
  - LKC site hit record 1,035 this past Saturday (site itself- not sure if this is Holiday Guide or main page)
  - Numbers from Jim Evers: \$6399 in commitments made (\$770 yet to be received)
  - Highlights from Sales Report through 11-30-17:
    - -14 different clients to date
    - -25% of total revenue comes from monthly preview guide, but used by most clients
    - -Top 3 clients represent 67% of billing
    - -Meadowlark Music uses a blend of Featured promo packs and monthly preview guide
    - -Half of our advertisers have used LKC more than once

- -Of the 6 years the calendar has been in business, 2017 ranks #4 and if we bill \$500 more it will be the third best in total revenue.
- Audrey is meeting with Jay and Chip later today to discuss initial project manager handover.
- 7 representatives of LKC ad buyers will join us for the Dec. 6 Holiday meeting. They will be recognized along with the LKC team and LCRF members.
